## Spring & Summer 2021 | Guest & Testing Policies

### Guest Registration Information

All guests (including accompanied guests and house guests) must be registered with Concierge at least 24 hours prior to arrival. Members must pre-register their visit with Concierge via the Member Website.

Members are permitted to host up to 10 guests using amenities per day per membership. Each membership is granted 140 guest days per season and each guest may have 8 guest days per season, across memberships. Members may designate 2 accompanied guests to have up to 16 guest days per season. These 2 named guests cannot change during the season.

Guests may only be registered by the Primary Member. The Primary Member, Spouse, or Significant Other noted in the Membership Documents must be present for guests to use amenities.

Unaccompanied guests are not permitted to use Club amenities and will be considered house guests only. Unaccompanied houseguests are strictly limited to using the roadways and hosting Member home. House guests are permitted access to Yellowstone Club property (to the member home only) at any time registered through Concierge but may not use Club amenities. Club amenities include but are not limited to skiing, golf, hiking/biking trails, outdoor activities, the Health and Wellness Center, Camphouse, restaurants, and lodges/Club facilities etc. *No fees will apply for unaccompanied house guests. House guest days are not counted toward the 140 guest limit per season.*

### Vaccine/Testing Information

If vaccinated, Members and Guests need to provide copy of CDC Vaccine Card and do not have to test. If not vaccinated, Members and Guests must follow these guidelines:

- **Pre-arrival Test:** PCR testing is required 72 hours or less prior to arrival at Yellowstone Club for all Members and Guests 9 years and older. This means a test must be taken in the 72-hour window prior to your arrival. Once the results are received, you will be permitted to use YC Amenities.
- **Arrival Testing:** All Members and Guests will be required to take an additional PCR test within 24 hours after arrival to YC. Testing kits will be available for purchase at the Main Gatehouse, Yellowmule Gatehouse and Concierge. You can use our LetsGetChecked testing option, or your own FDA EUA Approved PCR test, but all Members and Guest over the age of 9 must test again within 24 hours of your arrival to YC Property. You must submit your test results to Concierge once received.
- **On-Going PCR Testing:** For all Members and Guests staying at the Club, or in the Big Sky area, and using Amenities for more than 7 days, a PCR test must be administered every 7 days. These results must be submitted to Concierge when received. There will be no interruption of Amenity Usage while you await these results;
